- 3. \$450 Bundled fee. Includes Shipping/handling, wire, curative, Consumer Disclosure, closing, compliance review, scheduling and notary fee, disbursement and update.
- 4. \$500 Buyer bundled fee (purchase). Includes Shipping/handling, wire, curative, Consumer Disclosure, closing, compliance review, disbursement.
- 5. \$500 Seller bundled fee (purchase). Includes Shipping/handling, wire, curative, Consumer Disclosure, closing, compliance review, disbursement.
- 6. \$125 Notary fee
- 7. \$150 Notary fee
